



**"POINTS FOR KIDS" 2017  
OFFICIAL RULES**

- 1. Eligibility:** This promotion is open to all members of the Finger Lakes Gaming & Racetrack Lucky North Club, who are 18 years old or older, and abide by the rules and regulations of the Lucky North Club. Five (5) winners will be selected in all. Points for Kids is a program which helps to provide toys, clothes, and other necessities to local foster children in the Ontario County region. Members must check in at the Lucky North Club to donate points.
- 5. Prize(s):** There will be five (5) \$100 gift cards awarded on Tuesday, December 12, 2017. Winners will be notified. Each winner may request a \$100 cash alternative in lieu of a \$100 gift card.

6. **\$100 Gift Card Drawings:** The \$100 gift card drawings will be held prior to opening on Tuesday, December 12, 2017. Participants who donate at least one point between 11/23/17 and 12/10/17 will be automatically entered into the electronic drawing on December 12 2017. Members receive one entry per every point donated. Winners need not be present for the drawing to win. Limit one gift card drawing prize per Member. Each winner may request a \$100 cash alternative in lieu of a \$100 gift card.

Each registered entry is issued an individual number randomly assigned via a virtual drawing program. This program then conducts a randomized drawing which selects the winning number and then matches it back to the Member associated with that number.
